


CLIN 1005 increase Estimated Hours by 1,600 hours from 1,600 hours to 0 hours. CLIN 1006 increase Estimated Hours by 2,080 hours from 1,920 hours to 4,000 hours. CLIN 1007 increase Estimated Hours by 80 hours from 1,920 hours to 2,000 hours. CLIN 1008 increase Estimated Hours by 1, 040 from 960 hours to 2,000 hours.
