

**DETERMINATION AND FINDINGS FOR  
A SOLE SOURCE CONTRACT**

**FINDINGS**

**1. AUTHORIZATION:**

D.C. Official Code § 2-354.04, 27 DCMR 1304 and 1702

**2. MINIMUM NEED:**

The Government of the District of Columbia, Child and Family Services Agency (CFSA), has an need for a contractor to provide system evaluation to evaluate a federal demonstration project involving the use of federal funds to enhance the existing Family Treatment Court of children and families that CFSA serves. Under the requirements of the grant-funded enhancement project, CFSA is required to engage in a third party to conduct a project evaluation which shall include the process evaluation and an outcome evaluation.

**3. ESTIMATED REASONABLE PRICE:**

\$32,946.25

**4. FACTORS WHICH JUSTIFY SOLE SOURCE PROCUREMENT:**

- (a) The proposed provider, Coordinated Care Services (CCSI), previously performed services in this capacity for the District and is aware of the services to be provided. CCSI provides project research and evaluation services to state, county, and local human services agencies throughout the northeastern United States.
- (b) The provider, CCSI, is presently engaged as the system evaluation vendor for the three below discrete, but coordinated federal grant projects being administered by District agencies within the human services cluster:
  - 1. DC Department of Mental Health administers the federal Substance Abuse and Mental Health Services Administration (SAMHSA) System of Care (SOC) grant; and,

2. CFSA administers the Administration for Children and Families (ACF) Initiative to Improve Access to Needs-Driven, Evidence-Based/Evidence-informed Mental and Behavioral Health Services in Child Welfare (“Trauma” or “Trauma-Informed”) grant, and;
  3. CFSA administers the District of Columbia’s Title IV-E waiver demonstration project approved by the Administration for Children and Families (ACF) Initiative.
- (c) The provider, CCSI, had a contract to be the SOC/Trauma grant evaluator through an open procurement Request for Proposal (RFP) process. CCSI was the best qualified respondent for an evaluation engagement that is very similar to that which is required of the enhancement project.
- (d) There is a natural alignment of systems evaluation processes and responsibilities across the federal grants and the waiver demonstration, such that engaging a single entity to perform the evaluation for all four projects would maximize District resources, increase process efficiencies, and enhance the validity of evaluation results. Due to their previous involvement CCSI is the only provider who can immediately mobilize to provide this service to CFSA.
