

**DETERMINATION AND FINDINGS
FOR A
SOLE SOURCE PROCUREMENT**

CAPTION: Refurbish Existing Grapplers
PROPOSED CONTRACTOR: Northshore Manufacturing
PROGRAM AGENCY: Department of Public Works

FINDINGS

1. AUTHORIZATION:

D.C. Official Code §2-354.04, 27 DCMR 1304, 1700 and 1701

2. MINIMUM NEED:

The Department of Public Works (DPW) has six existing grapplers which were all manufactured by Northshore Manufacturing. DPW is replacing two of the grapplers with new units and will refurbish the remaining four. Any useable spare parts will be stocked for future repairs. The contractor must be an authorized service dealer to provide the required services.

3. ESTIMATED REASONABLE PRICE:

\$476,500.00


4. FACTS WHICH JUSTIFY SOLE SOURCE PROCUREMENT:

- A. All of the existing grapplers were manufactured by Northshore Manufacturing.
- B. The existing grapplers were specifically designed for the District and were procured through a competitive procurement process as part of the rehabilitation of the transfer stations.
- C. Once the units are refurbished, any useable spare parts will be compatible with that equipment. In addition, DPW currently has a stock of parts for these grapplers.
- D. A recent competitive procurement was conducted for the purchase of new grapplers. The only bidder was Northshore Manufacturing.
- E. Northshore Manufacturing has indicated in the attached letter that it is the only contractor that can refurbish the grapplers.
- F. Based on D and E above, no further market research was conducted.

I hereby certify that the above findings are true, correct and complete.


