FINDINGS

1. **AUTHORIZATION:**

D.C. Official Code § 2-354.04, 27 DCMR 1304 and 1702

2. **MINIMUM NEED:**

The Government of the District of Columbia, Child and Family Services Agency (CFSA), has the following minimum need:

- (a) The Government of the District of Columbia, Child and Family Services Agency (CFSA) has a need to provide trauma focused therapy to children and/or families who are in the care of the District of Columbia, Child and Family Services Agency CFSA.
- (b) CFSA has an urgent need for trauma focused therapy services in order to assist CFSA in maintaining its compliance with the LaShawn A. v. Gray Implementation Plan.

3. **ESTIMATED REASONABLE PRICE:**

\$108,164

4. **FACTORS WHICH JUSTIFY SOLE SOURCE PROCUREMENT:**

- (a) The Child and Family Services Agency, as part of the ongoing *LaShawn A v. Gray* federal litigation, is required to provide services that will enable CFSA youth to successfully transition out of the child welfare system;

- (b) CFSA youth received Individual and Family trauma focused therapy services from the proposed Contractor, which was funded by Crime Victims funds. Crime Victim Funds have since been depleted. However, continued clinical services are still necessary for the clients' well-being.
- (c) In view of the CFSA clients' previous history and trauma, their extreme positive relationships with their therapists, and the transitions between foster and adoptive placements and among Social Workers, it is essential to preserve the clinical relationships the clients have with their current providers so as to ensure continuity of care, thereby promoting the best interest of the children.
- (d) The current vendor provides trauma focused therapy to children and/or families; in accordance with their established treatment plan. The vendor is currently providing services to CFSA clients and it would be detrimental to their progress if services were disrupted.
