FINDINGS

1. AUTHORIZATION:

D.C. Official Code §2-354.04, 27 DCMR 1304, 1700 and 1701

2. MINIMUM NEED:

The Government of the District of Columbia, Child and Family Services Agency (CFSA), has the following minimum need:

- (a) The Government of the District of Columbia, Child and Family Services Agency (CFSA) has a need to provide gift cards to wards and families of Washington, DC.
- (b) CFSA has an urgent need for the gift cards in order to assist CFSA youth that have an emergency need for household or personal items.

3. ESTIMATED REASONABLE PRICE:

\$100,000.00 NTE

4. FACTORS WHICH JUSTIFY SOLE SOURCE PROCUREMENT:

- (a) There are 30 Giant locations in the Washington DC Metro area. However there are four locations in the urban city:
300 H Street NE store#2381
1400 7th Street NW store#2376
1050 Brentwood Rd NE store#0375
1535 Alabama Ave. SE store#0384

- (b) While the other 26 stores are located throughout the Maryland and Virginia suburbs. Giant is capable of meeting the CFSA minimum need. Giant Stores are located all in quadrants of the city where CFSA clients reside.
- (c) Giant stores are located in the areas where CFSA clients reside and as such can be reached easily by private vehicle, walking distance or public transportation within their immediate area wards they live in.
