

SECTION M - EVALUATION FACTORS

- M.1. Preference for Local Businesses, Disadvantage Businesses, Resident Business Ownerships or Businesses Operating in an Enterprise Zone**
- M.1.1 General Preferences**
- M.1.1.1** Under the provisions of D.C. Law 13-169, “Equal Opportunity for Local, Small, or Disadvantaged Business Enterprises Amendment Act of 2005” (the Act), the District shall apply preferences in evaluating bids or proposals from businesses that are local, disadvantaged, resident business ownership or located in an enterprise zone of the District of Columbia.
- M.1.1.2** For evaluation purposes, the allowable preferences under the Act for this procurement are as follows:
- M.1.1.2.1** Four percent (4%) reduction in the bid price or the addition of four (4) points on a 100-point scale for a local business enterprise (LBE) certified by the Local Business Opportunity Commission (LBOC);
- M.1.1.2.2** Three percent (3%) reduction in the bid price or the addition of three (3) points on a 100-point scale for a disadvantaged business enterprise (DBE) certified by the LBOC;
- M.1.1.2.3** Three percent (3%) reduction in the bid price or the addition of three (3) points on a 100-point scale for a resident business ownership (RBO), as defined in Section 2(a)(8A) of the Act, and certified by the LBOC; and
