**B.1** The District of Columbia Department of Real Estate Services (DRES), for the District of Columbia Government (District), is seeking a contractor to provide all labor, materials, equipment and supervision for the ADA Compliance Design at DC General ACC and Family Shelter.

**B.2 IFB - OPEN MARKET SOLICITATIONS (CONSTRUCTION)

For construction contracts in excess of \$250,000 at least 35% of the dollar volume of the contract shall be subcontracted in accordance with section M.1.6.

**B.3** The District contemplates award of a firm fixed-price contract. The estimated price range for this requirement is between \$500,000.00 and \$1,000,000.00.
