Change paragraph L.25.2 to L.24.2

2. Add the following paragraph to Section L.

L.25 SPECIAL STANDARD OF RESPONSIBILITY:

L.25.1 As evidence of qualifications for this project, at a minimum, bidder shall submit the following information with the bid:

L.25.1.1 The bidder or its proposed contractor shall submit verifiable references for three (3) completed roofing projects within the last five (5) years similar in size and scope to the solicitation project. References shall include the following information:

- Name, location and description of the roof project;
- Bidder's role on the project;
- Name, telephone number of client contact person;
- Total contract amount; and
- Contract period of performance.

L.25.1.2 The bidder shall submit with the bid a copy of its or proposed subcontractors roofing license and evidence that the bidder or its roofing subcontractor is a certified roofing company (such as GAF, Firestone, etc.).

L.25.1.3 Bids submitted in response to the IFB shall be deemed nonresponsible and shall be rejected if the bidder fails to submit with its bid the above information required by Paragraph L.25.
