

This amendment is being issued to respond to the following questions from bidders: 1) Spec C.3.8 states "Overhead Guard", but Spec C.3.39 states "Cab" – which one is it? <i>Response: The District requires both of these components. The overhead guard gives added protection to the operator in case of rollover.</i> 2) Spec C.3.19 state 6 x 6 Tilt while Spec C.3.37 states 6 x 10 – which one do you need? <i>Response: The District requires the 6x10 tilt.</i> 3) Spec C.3.13 states a 48" carriage, but Spec C.3.35 calls for a 54" carriage – what is your requirement? <i>Response: The District requires the 54 inch carriage height.</i>
