

RESPONSE TO BIDDER'S QUESTIONS

1. Section C.2.1.1.2 states Wheelbase: Maximum 165 inches (C.2.1.2.3 states Minimum 60 inches Cab to Axle) Is this a crew cab?

This vehicle is a regular cab, the wheelbase remains the same.

2. Section C.2.1.1.3 Color Bright White (C.2.1.4.2 calls for Black) What color?

Section C.2.1.4.2 delete "Color: Black" insert "Color: Bright White".

3. Sections C.2.1.4.3 and C.2.1.4.7 calls out 24" Push Bumper (this will not leave any ground clearance).

The push bumper is required.

4. Section C.2.1.6.1 calls for Aluminum Spare, all aluminum or just the spare?

Section C.2.1.6.1 is revised to read as follows "All Wheels and Spare : 19.5 inch polished aluminum".

5. Section C.2.1.26.18 (g) Dual Winch System: Variable Speed: Dual 18000 lbs each (Did you mean 8000 LBS)?

Section C.2.1.26.18 (g) is revised to read as follows "Dual Winch System: Variable Speed: Dual 8000 lbs each".
