**A2.** The District will require all produces as listed in the solicitation. If any item is not available in the market, then Section C.4 Substitution will apply.

**Q3.** CLIN 0041 and CLIN 0042, these are brand name products and sold in different grades. Can we get the MFG. number on these items?

**A3.** The District will accept any of the items as long as it meets the description regardless of the grade.

**Q4.** CLIN 0043 through CLIN 0045, same question applies as it did in CLIN 0038 through CLIN 0040?

**A4.** The District will require all produces as listed in the solicitation. If any item is not available in the market, then Section C.4 Substitution will apply.

**Q5.** CLIN 0046 same question as in CLIN 0043 through CLIN 0045?

**A5.** The District will require all produces as listed in the solicitation. If any item is not available in the market, then Section C.4 Substitution will apply.

**Q6** CLIN 0048 and all that follow in the thermal underwear sold in sets. Will you accept tops and bottoms packaged as each or will they need to package in sets in the same pack?

**A6.** The District requires these to be provided as a set.
