

DCRL-2012-H-0076 is hereby amended as follows: Delete Section H.10.4.9 in its entirety and replace with the following: H.10.4.9R For Independent Living Main Facilities, the Provider shall ensure a minimum of one (1) Direct Care Staff member be on shift 24 hours per day even if all residents have off-site, day-time schedules. The Provider shall have staffing patterns that allow for children/youth to remain in their assigned home if sick, and have the ability to return to and enter the site for any unannounced change in their daily schedule. The Provider shall have two (2) Direct Care Staff present at all times there is a resident present in the facility. See Page 2 for continuation.

2. Add section H.10.4.9.1 as follows:

H.10.4.9.1 An independent living program **that operates a main facility shall have a** minimum resident to counselor ratio of 10:2 during the daytime, 6:2 at evenings, and 15:2 at night

H.10.4.9.1.1 An independent living program that operates a residential facility shall have a minimum resident to counselor ratio of 15:1.

H.10.4.9.1.2 A counselor on duty shall be awake and available at all times to all staff and residents through a pager or telephone whose number is conspicuously posted in the main facility and each residence and provided to the contracting entity and licensing agency.

H.10.4.9.1.3 An independent living residential facility shall have a counselor on call and available to residents 24 hours a day pager or telephone whose number is conspicuously posted in the main facility and each residence and provided to the contracting entity and licensing agency.

3. Section H.10.4.6.1.D is amended by adding the following to the end of the section:

Direct Care Staff are defined as counselors, resident counselors or youth care workers.
