

This Amendment provides responses to clarifications requested: 1) How many (or average number) of consumers are expected to participate in the first year? or an anticipated number over the 4 years? <b>Answer:</b> We expect about 100 clients in the first year (50 are only for Family Treatment Court). 2) A clarification is requested on the itemized budget. <b>Answer:</b> There is now no requirement for an itemized budget. <b>Add the following to Section C.4.1.9:</b> The Recovery Specialists (RSs) shall provide one on one support for the client by assisting the client navigate the process to obtain, for example a birth certificate or ID, as well as advice on life skills. No classes shall be provided by the contractor. Any direct support is through the RSs directly and not by other facilitators and providers as those direct services can be accessed through existing CFSa resources. <b>The contractor shall insert pricing for the Base Year and the Option Years in the Price Schedule, Sections B.3.1 through B.3.5.</b>  <b>The due date for submission of offers is hereby extended until April 28, 2014 by 2:00pm.</b>
