

The Contractor shall be paid for CLINs 004, 005, 006, 008, 1001, 1002, 1003 and 1006, upon delivery and acceptance of the CLIN by the District.

**H.24 OWNERSHIP OF DATA**

All data first produced in the performance of this Contract shall be the sole property of the District. The Contractor hereby acknowledges that all data, including, without limitation, computer program codes, produced by Contractor for the District under this Contract, are works made for hire and are the sole property of the District.

Pursuant to sections I.5.1, I.5.2, I.5.3, I.5.4, and I.5.5, the Contractor shall provide upon request of the District any District data elements captured by the Contractor in the Medicaid Patient Data Hub in the format specified by the District. These data elements include but are not limited to, data base interfaces, design documents, project work plans, training materials and manuals, and Master Patient Index files and programs.

Only one (1) copy of this amendment is being sent to offerors. Sign and attach a copy of the amendment to each copy of your proposal submitted to the District, and return to the address listed above. In the event your proposal has been previously deposited, submit this amendment by sealed envelope, identified on the outside by solicitation number and proposal closing date.

This amendment, together with your proposal, must be received in this office prior to the time set for receipt of proposals.

Revisions or price changes occasioned by this amendment must be received in this office prior to the submission date set for receipt of proposals.
