

Question 1: What is the expected volume of referrals per month? Should we expect to have to perform the evaluations on more than Wednesday and Saturday per month?

Answer 1: 25 -30 per month. Rarely, most of the time it Wednesday evenings and Saturday mornings

Question 2: Are the evaluations scheduled for us?

Answer 2: Yes, Department of Corrections schedules evaluations

Question 3: Is there a specific format for the reports?

Question 4: Are some of the contents of the testing packet provided such as the Applicant's Disclosure & Release Form?

Answer 4: No, Contractor shall provide

Question 5: Is it possible to use psychology associated (unlicensed individuals in the field of psychology who are under the supervision of a licensed psychologist)?

Answer 5: No

Question 6: Is there a clinical contact person with whom we could discuss the precise process of conducting these evaluations?
